REPORTS:

Cemetery:

1. New flagpole to be purchased for Union cemetery for a cost of approximately \$150.

Roads:

- 1. Trustee Bev Haar will follow up with Jim Moore, Ottawa County Engineer, regarding the Hetrick culvert on Portage River South Rd.
- 2. Further discussion on potential security issues at township garage during SR-51 bridge project.
- 3. Detour signs have been placed to direct traffic flow from Schultz to Elmore East to 590, to relieve some wear and tear on Netcher Road from PRS slide detour.
- 4. Sanitation Dept found a water pipe under Hyde Run, which is reported to be in need of repairs. However, this is not a Township water line, and therefore should not be our responsibility.
- 5. McGinnis reviewed the government cell phone plan through First Net. \$45 per smart phone line. This is slightly more than the reimbursement stipend for phone coverage, but the cell contact number would remain with the township upon termination of employment. After discussion, Trustees vetoed unanimously the issuance of cell phones by the Township for road and cemetery employees. McGinnis to cancel the fire cell line, set up the modem for EMS unit 447, and combine Verizon bills under the current plans.

Fire/EMS:

- 1. Run report for Benton township, runs down, Trustees ok'd to bill for 2019 runs and 2020 agreement per contract
- 2. Fiscal Officer (FO) questioned if Trustees wanted to begin paying utilities against Fire levy fund rather than general fund. FO to obtain amounts in question. EMS points/runs for fire chief as an EMR to continue to be expensed again Fire/EMS fund.
- 3. Receipt of requests for billing adjustments from GLBA. FO advised patients pursue financial assistance application before requesting adjustment.
- 4. Cameras ordered for EMS bays, squad 448 going down to Braun end of January to repair sliding door (no quote, t&m), then squad 449 later. Oil changes to be completed on both squads upon return.
- 5. Chief introduced Cameron and Lucy, who are interested in learning and helping at the station. Scout Explorer program discussion. More information needed on job duties, liability coverage, adult supervision. Chief said scout executive meeting with officers at next officers' meeting 2/9. Woodville used to have an explorer program, Gibsonburg currently has an active program on their own, not through Boy Scouts. Have 5-6 youth interested in program. Teach how to roll hose, parts and piece of trucks, clean up scenes.

Zoning:

1. No report.

Other:

- 1. Weather stripping around overhead doors needs replaced. Lost its rigidness and doesn't stay in place. #448 needs done, possibly 449. Will look at all others while here. Will get quote from Northwood Door for operators Also need to budget for door operator replacement. #447 failing, hit or miss. All really need to be replaced, maybe a couple a year.
- 2. Deb and Carlo Pocino assisting with painting lockers.
