The Board of Trustees of Harris Township, Ottawa County, met in regular session on Monday, February 21, 2022, with the following officials present: Trustees Beverly Haar, Jerry Haar, DJ Greenhill, and Fiscal Officer Laura Hazel. Chairman Beverly Haar called the meeting to order at 7:30 pm.

The minutes of the February 7, 2022, regular meeting, were read by Chairman Beverly Haar and approved on a motion made by J. Haar and seconded by Greenhill. **Motion carried**.

#### **FINANCIAL**

A motion was made by Jerry Haar and seconded by Beverly Haar that the attached list of bills totaling \$23,456.08 be approved as the lawful obligations of Harris Township and that the Fiscal Officer be permitted to issue warrants in favor of the same. **Motion carried.** 

#### **REPORTS**

### Financial/Administrative:

- 1. The Ottawa County Engineer's annual meeting and luncheon will be held April 12 at the Ottawa County Fairgrounds. This meeting will also serve as the quarterly county township meeting.
- 2. Findlay is organizing a OneOhio Opioid response for Region 17. This included Harris Township and trustees are seeking more information about what will be involved.
- 3. Fiscal Officer requested approval for <u>supplemental</u> temporary appropriations and authorization to encumber funds:
  - a. Freightliner snow plow repairs (RDS2031) \$7,000 & Annual firefighter physicals (2021 PO closed) (FIRE2282) \$18,750

Greenhill moved to approve additional supplemental temporary appropriations as stated and to issue purchase orders as required to encumber funds; B. Haar seconded the motion. **Motion carried**.

### Zoning:

1. The Zoning Appeals Board and Zoning Commission will meet February 22 to continue work on reviewing the zoning code.

#### Cemetery:

1. Johnson questioned whether holes in the cemetery roads should be repaired with cold patch when weather permits in the spring. The patch made around the drain near the garage seems to be holding well. Trustees discussed getting estimates from contractors doing township road repairs this summer to learn what costs may be involved in resurfacing the cemetery roads. Greenhill will contact a company about a procedure he found interesting at annual convention in which the grindings of a road are recycled on

- the site. They are reapplied with additional binder back on the road where obtained. There is cost saving and the process has been used in neighboring communities.
- 2. Fiscal officer will post the job opening for part time cemetery seasonal mowing on line.

#### Roads:

- 1. Johnson reported that no estimates have been received yet for repairs to the equipment from winter storm damage.
- 2. Due to a mix up in matching the serial number of the new backhoe to financing agreements, a new replacement backhoe with correct serial identification will be provided at no additional cost to the township.
- 3. A discussion about an oil treatment for the Ford pickup was discussed to protect recent repairs made to the box. Cost will be about \$300. While trustees agreed this would be beneficial, it was decided to wait until spring to have this treatment. Larger trucks and fire apparatus would cost \$750-\$800 if consideration is to be given to doing more treatments in the future. Treatments would last about 3 years. After that, treatments should be applied every other year.
- 4. Road maintenance was reviewed. Cary and Andy will tour the road conditions prior to the annual road tour with the county engineer. Following the resurfacing plan that was developed several years ago, projects identified for 2022 include lining the culvert on Portage River South between Slemmer and Harris Salem, resurfacing Lickert-Harder and Slemmer with chip and seal, and applying Reclaimite to Portage River South between SR 590 and Slemmer which was resurfaced in 2020. B. Haar will contact the company to get estimates.
- 5. Johnson expressed concern about not getting edge lines as part of the contract when Hessville Road was resurfaced last fall. Cost was a deciding factor. Trustees encouraged Cary to add Hessville to other roads needing striping when a list is compiled in the spring.

### EMS/Fire:

- 1. Wilburn reported that positive comments were received about the annual appreciation dinner held February 19. Eighty-three were in attendance.
- 2. Wilburn requested purchasing hoses to replace those recently damaged at emergent incidents: two 25 foot and one 50 foot. Cost will be approximately \$400 plus inflation increases. Trustees approved the expenditure.

## **Building/Grounds**

- 1. Wilburn reported that the drywall repair in the women's lavatory is to be done.
- Trustees advised purchasing additional carpet tiles matching those newly installed at the station. This would offer protection against discontinued patterns, etc. which could occur in the future.

Communications, Announcements and other: none

There being no further business, a motion to adjourn was made by Jerry Haar and seconded by Beverly Haar. Chairman Beverly Haar declared the meeting duly adjourned at 9:00 pm.
