The Board of Trustees of Harris Township, Ottawa County, met in regular session on Monday, March 21, 2022, with the following members present: Trustees Beverly Haar, Jerry Haar, and DJ Greenhill and Fiscal Officer Laura Hazel. Chairman Beverly Haar called the meeting to order at 7:30 pm.

The minutes of the regular meeting held March 7, 2022, were read by Chairman Beverly Haar and approved on a motion made by DJ Greenhill and seconded by Jerry Haar. **Motion carried.**

FINANCIAL

A motion was made by DJ Greenhill and seconded by Jerry Haar that the attached list of bills totaling \$15,684.98 be approved as the lawful obligations of Harris Township and that the Fiscal Officer be permitted to issue warrants in favor of the same. **Motion carried.**

REPORTS

Financial/Administrative:

- 1. Trustees reviewed invoices, signed checks and vouchers, reviewed and initialed payroll, reviewed and signed purchase authorizations, and approved supplemental temporary appropriations.
- 2. Application for parks/trails improvement grants was received. No action taken.
- 3. Great Lakes Collection Agency (billing agency for Harris EMS service) advised cancelling services with Medical Mutual and Ohio Anthem due to out-of-network payment policy changes with these companies. Fiscal Officer to issue letters to agencies to cancel contracts at earliest date allowed by contract.

Zoning:

 Inspector Perry reported that the Zoning Appeals Board and Zoning Commission continue working on the township zoning code. Their next meeting will be April 20.
 Items needing more attention include working from home as many people changed their work patterns due to the pandemic. The zoning boards are also reviewing HB563 limiting short-term rentals to see the impact on our township and existing air bnb establishments, since there are now several in the township.

Cemetery:

- 1. Sexton Rodriguez reported that spring clean-up has begun and several trees need trimming. One tree by the garage needs to be cut down and Andy will get estimates.
- 2. Vehicles:
 - The Intimidator (side-by-side vehicle) needs servicing.
 - The Navigator is having warrantee work and servicing. The cost of repairs was \$235.16, with \$186 being warranty work.
 - The new Zero Turn (acquired by trade-in) is due to arrive in April.
- 3. We are waiting for an opinion from OTARMA risk management about hiring minors to do cemetery mowing and other part-time cemetery work. Employment posting continues.

Roads:

- 1. The annual road tour with the county engineers is scheduled for March 23.
- 2. Notice received that traffic monitoring will be done by ODOT; however, none are scheduled for within our area.
- 3. Salt: Clay Township has no more room for 50 tons of salt they contracted for 2021 and offered to sell it to us for \$50 per ton. After discussion, B. Haar moved to accept their offer and to order an additional 25 tons through ODOT bid. Greenhill seconded the motion. **Motion passed.**
- 4. It was suggested that there is a need for an incident reporting system.
- 5. Road Resurfacing: B. Haar made a motion for a resolution that due to the deterioration of Linker-Portage and Lickert Harder, they will both be chip and sealed this year, with the Ottawa County Engineer's office heading the projects. Portage River South from SR 590 to Slemmer Portage and Hessville from Yeasting to the county line will be treated with Reclamite preservative at a cost of \$27,291.60 per quote from Pavement Technoloy, Inc. Greenhill seconded. Motion passed.
- 6. Road Supt. Johnson reported that the loader tire is leaking but he lacks any jack strong enough to lift the loader to remove the tire. He will ask Jim Rose for suggestions.

EMS/Fire:

- 1. Chief Wilburn reported that the AFG grant application for a new tanker passed peer review at FEMA. There is no word yet on the radio grant.
- 2. Zoll will be requiring a "subscription" for access to a patient's 12-lead EKG report after initial transmission to the hospital. Currently the report is given both the hospital and the township EMS record; in the future it will only be provided to the hospital at no charge. We have 2 monitors, which will be billed at \$928.18 each for a three-year contract. Billing due in 365 days, and again at the end of year 2.
- 3. There is a need to reestablish an employee assistance program for counseling.
- 4. EMS Asst. Chief McGinnis said it is time, again, to look at our EMS program, staffing, and costs. The current EMS 5-year levy is due for renewal in 2023. Trustees plan to send it to the voters in November 2022, so a smooth transition will take place between the current levy's end in 2023 and the renewal, which cannot be collected until 2024. There continues to be a shortage of staffing throughout the state, which makes it difficult to maintain 24-7 coverage.
- 5. Chief Wilburn reported that 12 firefighters attended the fire school recently held at Penta.
- 6. Twenty-five helmets will be required to replace those no longer certified by July. That leaves 6 helmets still currently certified.

Building/Grounds

1. Wilburn reported that that a quote will be needed for repainting the restrooms in the fire station.

There being no further business, a motion to adjourn was made by Beverly Haar and seconded by DJ Greenhill. Chairman Beverly Haar declared the meeting duly adjourned at 9:24 pm.
