The Board of Trustees of Harris Township, Ottawa County, met in regular session on Monday, May 16, 2022, with the following members present: Trustees Beverly Haar, Jerry Haar, and DJ Greenhill. Fiscal Officer Laura Hazel was absent. Chairman Beverly Haar called the meeting to order at 7:30 pm.

The minutes of the regular meeting held May 2, 2022, were read by Chairman Beverly Haar and approved on a motion made by Jerry Haar and seconded by DJ Greenhill. **Motion carried.** 

## **FINANCIAL**

A motion was made by DJ Greenhill and seconded by Beverly Haar that the attached list of bills totaling \$23,545.86 be approved as the lawful obligations of Harris Township and that the Fiscal Officer be permitted to issue warrants in favor of the same. **Motion carried.** 

## **REPORTS**

Financial/Administrative: (Fiscal Officer's report)

**Zoning:** (Inspector's report)

1. Marilyn Metzger submitted her resignation from the Zoning Appeals Board.

Cemetery: (Sexton's report)

- 1. The following deed transfers were made: 659, 660, 661, and 662.
- 2. It was suggested that the trustees consider having a survey of the newest land acquisitions so roads and lots could be plotted for future use. There is no plan to actually allow purchasing of lots in these sections at this time as adequate room is still available in current sections.

**Roads:** (Road Superintendent's report)

- 1. Identification signs for Smith and Hessville roads have been received.
- 2. Weed spraying along the roads has been completed on the north side of the township.
- 3. Discussion centered around obtaining fill dirt for the culvert lining project on Portage River South. Dirt could be obtained for free from the county. Mr. Hetrick offered dirt from his nearby property at a cost of \$1,000. The cost of the township transporting county dirt to the site made Mr. Hetrick's offer more economical. B. Haar moved and Greenhill seconded the motion to purchase the dirt from Mr. Hetrick. **Motion passed.**

 Property owner at the intersection of Ernsthausen and SR 105 has filled in a ditch in the township right-of-way with chunks of waste concrete. It is creating a mowing obstacle.
Haar will discuss solutions with C. Miller at county, and Johnson plans to discuss situation with owner.

## **EMS/Fire**: (Chief's report)

- 1. Captain Dave Rogers has announced his retirement from the Harris Elmore Fire Department effective in June. The trustees thanked Dave for his 29 years of service to our community.
- 2. As a result of Capt. Rogers retirement, Chief Wilburn has announced the following assignments for the department officers: Mike "Toby" Murray, 1st captain; Brian Richards, 2nd captain; Dan Dwyer, 1st lieutenant; and Josh Parlette, 2nd lieutenant.
- 3. Greenhill moved and J. Haar seconded that Cary Johnson and Josh Hobbs attend fire school which will be starting in the next few weeks. The township will pay 3/4 of the tuition and candidates will pay ¼, which will be refunded after successful completion of the course and probationary year. **Motion passed**.
- 4. Chief Wilburn has requested that 2-3 firefighters be allowed to attend classes for instructor certification for firefighters. This would allow for in-house training for firefighters. Currently, several EMT's have EMS instructor certifications which allows for in-house EMS raining.
- 5. Assistant EMS Chief McGinnis has submitted information about a state grant for Marcs radios. Costs of outfitting the department would be in excess of \$186,000. A dilemma has occurred because the township has applied for a FEMA grant for the radios but no information has been received about the progress on this grant. The state grant has a submission date in early June. McGinnis has been asked to research any conflicts if the township applies for both.

## **Building & Grounds:** (Jim Wilburn, building superintendent)

 Replacing mulch with river rock is being considered. Jim will check with several stone yards for the best price. B. Haar moved and Greenhill seconded putting in approximately 12 ton of stone at a cost of \$159 per ton. Motion passed.

There being no further business, a motion to adjourn was made by Jerry Haar and seconded by DJ Greenhill. Chairman Beverly Haar declared the meeting duly adjourned at 8:47 pm.
