The minutes of the regular meeting held January 2, 2023, were read by Chairman Beverly Haar DJ Greenhill motioned and Jerry Haar seconded that the minutes be approved. **Motion** carried.

#### **FINANCE**

- 1. Trustees reviewed invoices, signed checks and vouchers, reviewed and initialed payroll, reviewed and signed purchase order/blanket purchase orders.
- 2. A motion was made by Trustee Greenhill and seconded by Trustee B. Haar that the attached list of bills totaling \$16,661.39 be approved as the lawful obligations of Harris Township and that the Fiscal Officer be permitted to issue warrants in favor of the same.

#### **REPORTS**

Financial/Administrative: (Fiscal Officer's report)

- 1. A BWC claim was made on Dec. 15, 2022. Hazel suggested the need for an internal incident report to aide in certification of claim process.
- 2. A certified notification dated Jan. 11, 2023, was received from Materion, per OAC, of Class 1 permit modifications dated 10/22/22 to Hazardous Waste Facility Installation and Operation Permit for the Elmore Plant.
- 3. Report of reallocation made for natural gas in December of \$85 for road maintenance building from account 2031-330-323-0000.
- 4. Trustee B. Haar, DJ Greenhill and Fiscal Officer Hazel will be attending OTA Winter Conference in Columbus Jan. 25-27. Greenhill moved to add an additional day lodging due to forecasted weather and training workshops. B. Haar seconded. **Motion carried.**

## **Zoning:** (Inspector's report)

1. The revised zoning code draft has been sent to Mark Messa, Regional Planning Director, and the Ottawa County Prosecutor for review.

- 2. The annual organizational meeting for the Zoning Commission and Zoning Appeals Board will be scheduled for later this month.
- 3. Annual notification received to file any newly enacted zoning resolutions/amendments with County Recorder per ORC.
- 4. Zoning Inspector Perry presented listing of 2022 zoning permits issued.

## **Cemetery**: (Sexton's report)

- 1. J. Haar moved and B. Haar seconded a motion to pursue the surveying of 2+ acres of land adjacent to Union Cemetery for possible acquisition. **Motion carried**.
- 2. Sexton is researching an OSS "Aim to be Green" recycling site grant. Possible uses include a cement pad under two recycle bins, a surveillance camera, and a digital sign. Trustees approved moving forward with the application.
- 3. Mower maintenance has been completed and mowers have been picked up from Bill's Implement to store for winter. Indoor storage was not available this year at Bill's.
- 4. Deed #675 issued.

# Roads: (Road Superintendent's report)

- 1. An estimate is being obtained from Bay Tractor for steering repairs to the John Deere long-reach mower.
- 2. A pressure tank is needed for the primary water system at the garage.
- 3. Due to the Easter holiday weekend and Veterans' Day occurring on second Saturdays of the month, junk collection will be moved to preceding week. Signs and notification will take place.
- 4. Two junk day concerns will be reviewed by trustees: weight/potential hazardous contents of burn barrels and tear-outs that should be privately disposed in roll-offs.
- 5. The annual road tour with the county engineers has been scheduled for March 21 at 9 am.
- 6. Superintendent will prepare the annual road striping plan before April for county engineers.
- 7. Trustees have received a proposed 6-year road resurfacing plan from Ottawa County Deputy Engineer, Craig Miller.
- 8. An agreement was signed to plow snow/salt at Grace Lutheran Church for the Senior Center for 2023.

EMS/Fire: (Chief's report)

1. One applicant for fire-fighter school has a work conflict preventing him from attending local drills. He will be allowed to attend school but will have to personally pay the entire tuition. Upon successful completion, he will be reimbursed for the total amount in

December 2023.

2. Remedial course available to another candidate who did pass his 36-hour course. There will be no charge by Vanguard for this remediation; however, he will have a \$25 test with

proctor in the spring.

3. Brad Gilbert will not be renewing his card and will be retiring from the fire department

effective July 28, 2023. He will remain available as a consultant.

4. The trustees and the fire department want to thank Washington Township for supplying approximately \$10,000 of equipment in appreciation of HEFD emergency coverage to its

township.

5. B. Haar moved and Greenhill seconded the purchase of two bags for ropes and eight

1-3/4" replacement hoses at a cost of \$2,075. **Motion carried**.

6. Fire chief submitted officers' suggestions for changes to department pay schedule. No

action was taken.

7. There has been no news about the grant for a new tanker.
