- 1. Huntington National Bank is increasing OPCS floors to 60% in compliance with the Ohio Treasurer of State.
- 2. Current township levies were discussed. In accordance with ORC, B. Haar moved and J. Haar seconded that a renewal levy of 3.8 mills for the Fire/EMS fund be placed on the November general election ballot. Motion carried; resolution of necessity issued to levy a tax in excess of the ten-mill limitation certified to the county auditor to obtain total current tax valuation and dollar amount of revenue that would be generated. Efforts will be made to remind residents that the levy must say "fire/EMS" because that is how it is worded under the ORC; however, funds will continue to be used for fire expenses since a separate levy for EMS currently exists.
