Approval of Minutes

The minutes of the regular meeting, held Monday, October 6, 2025 were read by Chairman Beverly Haar. Trustee D. Greenhill made a motion to accept the minutes as written; Trustee J. Haar seconded the motion that the minutes be approved. **Motion carried.**

Budget/Administrative - Fiscal Officer report (Laura Hazel)

- Hazel presented Ohio Township Association education renewal subscription for \$250 to the Board. Trustee B. Haar agreed it is a good resource for the cost and approved proceeding with the subscription, with Greenhill and J. Haar also in agreement.
- Discussion on setting reserves for capital improvements per ORC. Hazel looking for more information from Prosecutor's office, AOS regional office, and county auditor regarding reserve account designations and county budget committee restrictions on levy funding in the future.

Zoning – Inspector's report (Paul Perry)

Fire - Chief's Report (Jim Wilburn)

- No Chief's report
- Asst. Chief Berkel reported that hydrant markers were ordered and placed along S.
 Portage River Rd.; decals to be ordered from Vision Quest for the trailer, appx cost
 \$1710, also to include donor's names; will be listing boat on gov.deals for \$5k;
 Hovercraft expected completion early November, when 3 employees will travel for
 training (A. Fertig, C. Johnson, D. Berkel)
- Berkel also has been working on quotes for building improvements: painting/powerwash \$14k; epoxy flooring \$28k-\$35k; lighting with motion sensors; sign replacement; and remodel of kitchen, radio room and chief's office.
- Discussion on upgrades to Windows 11, and cybersecurity requirements with HB96.
- Captain Murray reported on grants he's been looking into: MARCS grant, lighting, infrastructure
- Working with roads department for ramp for Hovercraft for entrance to Portage River.
- Lieutenant Berkel agreed to work with Fiscal Officer on cybersecurity requirements.

Trustees discussed options for health insurance and QSEHRA continuation. After
open discussions with input from AC Fertig and Perry, the health insurance quotes
are just not feasible. The cost for an employee only would be what we have been
contributing to QSEHRA, and the employee would still have the high deductible to
meet. Not to mention, the family cost was much higher than silver plans on
Marketplace. Trustees to consider increasing amounts once budgets are reviewed,
or possible wage increases for full time EMS employees.

New Business

 Pump testing completed 10/13 on fire engines. Per Overmyer, they all passed the pump test; however, there are some other issues to look at. #446 was not pump tested, as it will be part of NFPA "recondition", whether in whole or in part, per J. Berkel.
